When Micah and Emily opened Freidman's in 2012 he thought it would need a gimmick to stand out from the other diners in the area and so he cobbled together a smoked brisket burger that they call the "Free Burger". It's just a silly play on works from Friedman, but it took off and patriotic tourists will make a trip to Friedman's just to say they had a Free Burger. It helps that it's delicious!

Micah has never been good with money and his friends know that he's nearly 40 and still paying off student dept. Despite that he always takes care of the people in his life. He loves his wife and co-owner Emily, and he's the kind of guy who will make sure his staff get paid before he does. He's a hard worker who gets lost in the job, and you know he hasn't been on a date or anything else resembling a romantic get away with Emily in years.

## FRIEDMAN'S

Friedman's LLC was formed in 2011 by Emily Friedman and the diner opened in 2012 in Cape May, New Jersey. It has become a local tourist attraction primarily for its signature "Free Burger" which is a smoked brisket burger in the style of New York delis. In 2015 it was rated Cape May's #1 Diner by Eater Magazine.

In the past few years the tourist industry in Cape May has declined and Friedman's has gained less attention as focus moves away from the seaside resort.

10 Months ago, Friedman's was purchased by JBA Holding, a UK conglomerate focused on long term investment and retail markets. The terms of sale necessitate that Emily and Micah continue running Friedman's for a 12-month transitionary period, that they maintain at least 80% of the 2022 sales numbers, and that they train a replacement manager to run the business. During this transition year they are being paid a reasonable salary from JBA and will receive a large balloon payment once the transition is complete.

Since the contract was signed, Friedman's has done poorly. Their sales are down, they've let go of several staff, and there is no one who has been appointed future manager. At this rate they may be in breach of contract with JBA or worse, the restaurant could fail all together.

Choose one that describes your outlook:
